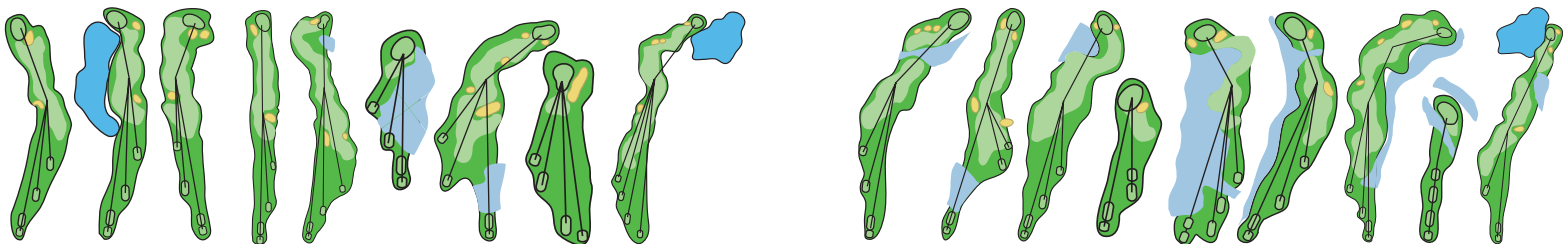
USGA rules govern play except as modified by local rules.

Course Rules & Information

- Lyon Oaks is a non-metal spike facility
- Proper golf attire and etiquette required
- Starters will decide upon starting hole, grouping and tee selection
- Each player must have their own clubs and bag (rental clubs available)
- Non-golfing walkers not permitted
- Play Ready Golf. Pace of play is 4 1/2 hours for 18 holes.
- Please replace divots, repair all ball marks on greens and rake bunkers.
- All wetlands are environmentally sensitive. Please refrain from entering.
- Flag color designates hole location: Red-Front, White-Middle, Blue-Back.
- All yardage markers are measured to the center of greens.
Red-100 yards Blue-200 yards
White-150 yards Black-250 yards

Cart Rules

- Lessee is responsible for any damage to golf carts or property
- Must be at least 18 years of age with valid driver's license to operate cart
- A non-golfer must be at least 16 years of age to ride in a cart
- Carts (pull carts included) must remain on paths around all tees and greens
- Only two riders per cart
