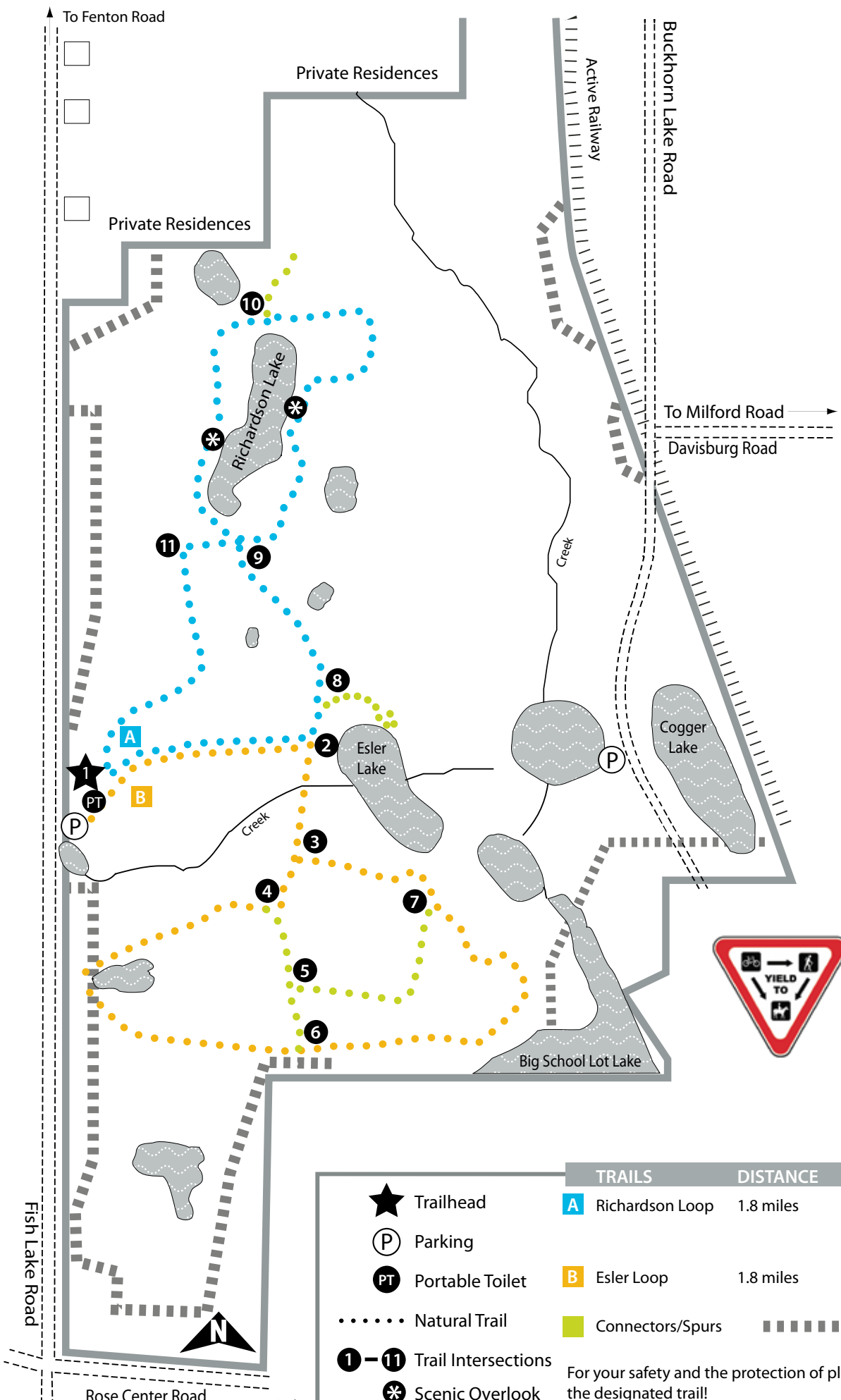

RULES

1. Permitted uses:
hiking, equestrian, recreational biking,
cross-country skiing (ungroomed), geocaching
and letterboxing.
2. Seasonal archery hunting for white-tailed deer
is permitted within the park Oct. 1–Jan. 1.
Separate archery hunting map/rules available.
3. Please stay on designated trails. Do not hike off
trail or blaze new trails.
4. Park is open approximately 30 minutes before
sunrise to 30 minutes after sunset, or as posted
at entrance.
5. Pedestrians yield to horses. Keep right except
to pass. Bicyclists must yield to pedestrians and
horses.
6. Leave no trace. Properly dispose of all garbage
and pet waste in receptacles provided.
7. Collection, destruction, or taking of plants,
wildlife, and natural surroundings is prohibited.
8. Dogs are permitted if confined on a leash not
exceeding six feet in length. All pets must
have proper vaccinations. Field dog training
prohibited. Owners must clean up pet waste.
9. Help keep the Oakland County Parks safe,
clean and well-maintained. Report accidents
or vandalism to the Oakland County Sheriff's
Office at 248.858.4950.
10. Report all injuries or a problem on the trail to
park staff at 248.858.0906.
11. In case of an emergency, dial 911. Park
